As you know, the issues on the registration of foreigners upon place of stay, extension of

The State Migration Service is one of the state bodies where foreigners apply in the Republic of Azerbaijan. Along with providing services related to migration to foreigners by the Service staff,



permanent residence, as well as work permits to carry out paid labor activity, reception of applications related to acquisition, restoration and termination of citizenship, as well as establishment of citizenship and determination of refugee status, readmission issues and measures against illegal migration are carried out by the State Migration Service.

A number of serious steps have been taken and major activities have been carried out in the field of legislation and its application for management and regulation of migration processes. Amendments made to the migration legislation, taking into account international practice, regarding registration



of foreigners upon place of stay, their staying and residence in the country, as well as work permits are indicators of flexible migration policy and are aimed at development of the country. Thus, development of tourism and business environment is directly related to migration issues. In general, the purpose of the amendments made to migration legislation is improving conditions of citizens, foreigners, as well as migrant workers, free enjoyment of their rights, increasing their satisfaction, providing their convenience.

We are interested in informing foreigners using migration services, as well as our citizens about the procedures applied by the legislation. As our analyses prove that in some cases foreigners violate the legislation and are brought to administrative liability due to the lack of information. The role of awareness raising events is great in eliminating this problem, as well as making them feel more confident and informed. Awareness raising events, mobile

services, Open Door Days are held all over the country by the State Migration Service.

Along with the above mentioned, today, special attention is paid to ensuring citizens' satisfaction by the State Migration Service. Following the instructions and recommendations of the President of the Republic of Azerbaijan, as well as in accordance with requirements of the "ASAN Service index", in order to provide

transparent and quality services to citizens, ensure their convenience, Service point of the Baku Regional Migration Department was put into operation after substantial reconstruction. At present, relevant measures are continued in the direction of providing the activity of the Service points of the Regional Migration Departments in compliance with the same requirements.

Furthermore, in order to solve the problems of foreigners who violate the requirements of migration legislation in the territory of the country, to provide flexible and on-site services, to ensure accessibility of the provided services in the field of migration for foreigners visiting and residing in the regions, as well as citizens, to raise their satisfaction and awareness of migration legislation migration units providing 24-hour service were established at the "Samur", "Astara" and "Shikhly" border checkpoints last year. In addition, continuous activity of the Call Center - (919 telephone number) in 3 languages -Azerbaijani, English and Russian is very important in terms of ensuring the rights of obtaining necessary information and raising awareness in the sphere of migration by citizens, as well as foreigners.

Application of modern technologies and innovations in the management of migration processes, as well as development of the "MigAz" application, inclusion of a labour visa in the list of visa types in the "ASAN Visa" system serves to improving the legal status of the citizens, foreigners, as well as migrant workers, providing their convenience. Thus, we can say with



confidence that today the rights and freedoms of foreigners are fully ensured.

I want to specially emphasize one point that one of the fields which President Mr. Ilham Aliyev keeps in the center of attention is the youth policy. Specific programs are carried out by our state for the purpose of uncovering the intellectual and creative potential of young people, their education abroad, formation as a leader, taking worthy place in the society. As a result of the "Volunteer Movement" which has expanded in recent years, our young people have become irreplaceable members in the implementation of various projects among the society. A number of works have been done in this direction by the State Migration Service. So the "Migration Volunteer - You are different" project has been launched for the purpose of obtaining new knowledge and experience by young people, providing their personal skills with new opportunities. The purpose of the projects, events carried out in migration bodies is to serve citizens by more effective, transparent and easier ways and to ensure their satisfaction. The rendered services have been integrated into the "Electronic government" portal. Application and development of electronic services have been ensured, the application of new technologies has been expanded. The number of electronic services provided to foreigners has been increased from 11 to 14. In addition, the State Migration Service renders services in the "ASAN service" centers, as well.

I would like to mention that, at a time when the state support is strengthened to the private sector and entrepreneurship in the country, the State Migration Service holds regular meetings with employers within its competences in order to further expand the cooperation with entrepreneurs. Last year 7 meetings were held with the participation of about 800 entrepreneurs.

As a successful outcome of the implemented activities, the State Migration Service showed the highest result (68.98%) according to the report on the results of the assessment for 2017-2018 according to the "ASAN service index" in the Republic of Azerbaijan.

In 1993, when real danger emerged for our independence, Heydar Aliyev responded the call of millions of people. He came back to Baku from Nakhchivan. In October 3, 1993 he was elected the president of the Republic of Azerbaijan. With that, stability was restored in the country. After the conclusion of the "Contract of the Century" in September 1994, the oil strategy which brought billions to the country was set up. ## Migration legislation is improved

Amendments have been made to the legislation of the Republic of Azerbaijan related to migration to increase foreigner's and stateless person's (herein after – foreigner) satisfaction, to create conditions for more effective use of rights by foreigners having family ties and business relations in the country, as well as to improve the management of migration processes in accordance with the modern requirements.

The laws of the Republic of Azerbaijan on making amendments to the Migration Code and Code of Administrative Offenses dated July 14, 2018 have already entered into force.

According to the amendment to the legislation pursuant to Article 21 of the Migration Code foreigners or stateless persons who want to stay temporarily in the Republic of Azerbaijan for more than 15 days not 10 days will get registered upon place of stay.

According to the previous legislation if foreigners and stateless persons' permissions for stay and residence in the country, as well as for work are cancelled according to the relevant basis provided by the legislation, in any case those persons were being expelled from the country and their entry to the country were being restricted. Restriction on the entry of a foreigner, stateless person to the country for a certain period of



time in many cases created certain difficulties for the business sector, and entrepreneurs. According to the relevant amendments to the law, in case the grounds for cancellation of foreigner's and stateless person's permission for stay, residence or work in the country are removed, then the ban on entry of that person to the country will be lifted.

According to the previous version of the Migration Code if a foreigner or stateless person has been brought to administrative responsibility twice or more in the last three years for violating migration legislation, his entry into the country were being restricted for a period of five years. According to the changes, the provision of the Migration Code stipulating imposition of restriction on entry of a foreigner or stateless person to the territory of the country for a period of five years for the relevant grounds was repealed.

Another issue is about foreigner's and stateless person's departure and re-entry to the country who have been subjected to adminis-

trative corrective measures in the form of administrative fine for violation of migration legislation. From now on, for violating migration legislation foreigners and stateless persons who have been subjected to administrative corrective measures in the form of administrative fine without administrative expulsion will be able to leave the country without any restrictions on re-entry to the country if they do not pay the fine. In this case, their entry to the country is restricted until they pay the fine and after paying the fine restrictions imposed on their entry to the country are immediately lifted. Thus, there will be no need to additionally apply for lifting of the restriction. This approach will have a positive impact on increasing satisfaction in regulation of migration processes.

According to the amendments, when an application for a permanent residence permission is rejected, a mechanism regulating the issuance of a temporary residence permit on the basis of the documents submitted by that person is being

established. So that according to the change foreigners or stateless persons who have been rejected permanent residence permit will be able to apply to the State Migration Service with an application form without submitting additional documents for obtaining a temporary residence permit.

When it comes to addendum of new Articles 150.15 and 150.16 to the Code of Administrative Offenses if a person does not pay the fine within one month from the day the decision on application of administrative corrective measure in the form of administrative fine comes into legal force, 1 percent of the penalty amount will be charged as a late fee for each subsequent day, but not for more than 2 months. The change serves to increase foreigners' sense of responsibility.

The laws of the Republic of Azerbaijan on making amendments to the Migration Code and "Law on the state fee" have already entered into force.

According to the amendment to the legislation pursuant to Article 20.3 of the Migration Code if the citizenship of the Republic of Azerbaijan of a person who is the citizen of another state (country) along with belonging to the citizenship of the Republic of Azerbaijan has been terminated while he was in the territory of Azerbaijan Republic, that person has to leave the country within 30 days from the date he obtained official notification about it or in case of existence of arounds envisaged in article 45 of the Migration Code he has to apply

to the State Migration Service for obtaining temporary residence permit. During the period of processing such application the person is considered as temporary stayer in the territory of the Republic of Azerbaijan on legal basis.

According to the amendments foreigners and stateless persons temporarily staying in the Republic of Azerbaijan for more than 15 days should get registered upon place of stay within 15 days of arrival in the country. When a foreigner and stateless person changes his/her place of stay, he/ she should get registered upon new place of stay within 5 working days from the date of arrival at the new address.

As we know according to the Migration Code when a foreigner changes his/her place of stay, he/she should get registered upon new place of stay. So that according to the amendment 5 days for getting registered upon new place of stay have been determined for foreigners.

Another amendment is related to the extension of temporary staying period of foreigners in the country. If according to the previous edition 4 cases were determined for extension of temporary staying period in the territory of the Republic of Azerbaijan, now the number of those cases is 5. So that according to the added article extension of the temporary staying period of the father, mother, spouse, child, brother or sister of a foreigner in the Republic of Azerbaijan is considered as a ground for the extension of the temporary

staying period of the foreigner or stateless person in the territory of the Republic of Azerbaijan.

The number of the grounds for obtaining temporary residence permit for foreigners in the territory of the Republic of Azerbaijan have also been increased and 10 new grounds have been added to Article 45 of the Migration Code. Additions concerning foreigners who are considered victims of human trafficking or assist to criminal investigation bodies are the examples of it.

New clause concerning foreigners who are considered victims of human trafficking or assist to criminal investigation bodies are not required to obtain a work permit for carrying out paid labor activity in the territory of the country was also added to the Migration Code.

Another amendment is related to the issuance of temporary residence permit on the ground of depositing in the banks of the Republic of Azerbaijan in the amount of at least 100,000 manats on the basis of term deposit agreement. According to the amendment the list of foreigners, who have deposited in the banks money in the amount of at least 100,000 manats on the basis of a term deposit agreement, for obtaining a permit for temporary residence in the Republic of Azerbaijan shall be sent to the relevant bank by the State Migration Service within 3 working days. In case of decrease in the amount of term deposits of the foreigners indicated in that list is observed or the deposit

agreement is terminated, the bank should inform the State Migration Service within 3 working days.

According to the previous edition of the Migration Code when applications of foreigners and stateless persons for obtaining of a permit for permanent residence in the Republic of Azerbaijan were processed, no exception was intended for foreigners related to the requirement on checking their knowledge of rights and obligations provided for by the laws of the Republic of Azerbaijan and of state language. From now on this case shall not apply to children under the age of 18, foreigners or stateless persons who are above the age of 65 or disabled persons of group I (if the relevant confirming document is submitted) according to the amendments made to the legislation.

In order to simplify migration procedures in relation to foreigners who have invested in the economy of the country, as well as who deal with entrepreneurial activity a number of amendments have been made related to issuance of permit for permanent residence. So that foreigners who have invested at least 500,000 manats in the economy of the Republic of Azerbaijan will not be required a document confirming availability of funds required to meet minimum needs of themselves and family members staying with them in order to obtain a permit for permanent residence. Besides, according to Article 55.0.8 of the Migration Code when total number of days of foreigner's stay outside the territory of the

Republic of Azerbaijan in any year since the date of issuance of a permanent residence permit exceeds 180 days the permanent residence permit for him/her is not issued (or extended). After the amendments this Article will not be applied to foreigners who have invested at least AZN 500,000 in the economy of the country and who deal with entrepreneurial activity.

Large number of applications received by the State Migration Service of the Republic of Azerbaijan related to processing

applications submitted in connection with the issuance of documents certifying the right to stay and residence in the territory of the country and the issuance of work permits to carry out paid labor activity within a short period makes necessary to pay a special attention to increasing citizens' satisfaction in this sphere.

Taking into consideration the above mentioned, amendments

had been made to the Law on "State fee" to regulate the processing of applications related to documents certifying the right to stay and residence in the territory of the country and carrying out paid labor activity within short period taking into account requirements and periods envisaged by the legislation, to improve service quality, to increase usefulness and efficiency of activity, to develop payment possibilities for services.

So that different state fees have been determined according to processing period of applications related to issuance of documents certifying the right to stay and residence in the territory of the country, as well as issuance of work permits to carry out paid labor activity depending on the intention of foreigners applied. For example, if a permission card for temporary residence in the territory of the Republic of Azerbaijan of an adult foreigner up to 1 year is issued or its period is extended within 15 working days, state fee in the amount of 160 manats (100 manats for minor foreigners) should be paid, but if within 20 working days 120 manats (60 manats for minor foreigners) should be paid. For work permission issued or extended to foreigners to carry out paid labor activity in the territory of the Republic of Azerbaijan up to 1 year within 10 working days state fee in the amount of 1400 manats should be paid, within 15 working days 1200 manats and within 20 working days 1000 manats should be paid.

Regional Departments of the State Migration Service (SMS) operate in the regions to ensure convenience of the applicants, to prevent travelling long distance from remote regions of the country, as well as to expand the activity directions of the Service. 8 Regional Migration Departments – Baku, Shirvan, Aghsu, Yevlakh, Ganja, Khachmaz, Shaki and Lankaran are included in the system of the State Migration Service. Regional Migration Departments implement their activity in compliance with the legislation of the Republic of Azerbaijan.





#### Migration processes in Azerbaijan amid new challenges

fter independence, large scale of migration processes in Azerbaijan has become a phenomenon, which is rich with various determinants for both quantitative and qualitative indicators, as well as characterized with actuality arising from that. It is possible to assume that migration processes occurred in stages if we cast a look at the nature and manifestations of migration flows coinciding with that time. These processes can be conventionally divided into the following chronological stages: the first stage (1990-1995), the second stage (1996-2003), and the third stage (2004-2017).

In the first phase, the collapse of the Soviet Union, especially the ignition of the longest-lasting conflict in the South Caucasus - the Armenia-Azerbaijan Nagorno-Karabakh conflict, as well as the bloody events on ethnic arounds in the Fergana province of Uzbekistan in relation to the Meskhetian Turks the deportation of ethnic Azerbaijanis from western Azerbaijani lands in the early 1990s, settlement of hundreds of thousands of IDP's, forcibly displaced Nagorno-Karabakh and seven surrounding districts occupied by the Armed Forces of Armenia, in other regions of the country added ethnic colour to that stage.

As the second stage of migration processes is associated more with labor migration, it is considered to be economically motivated and the statistical data for this period are related to approximately one million Azerbaijani migrants engaged in labor activity mostly in Russia, Ukraine, Turkey and other countries.

The main part of the migration flows in Azerbaijan in terms of rates of immigration and emigration falls in the early 1990s due to known conflicts. While the quantitative indicators of those who left the country were equal to those who arrived during that period, in the second half of the 1990s the number of those who left the country was more than the number of those who arrived. However, since 2004, namely, the third stage of migration processes has started to change in the content. The nature of this stage is characterized with more consistent and institutionalized policy of the government in this field.

In a short period of time
Azerbaijan turned from the
country of origin to the country
of destination. For this reason,
the "Concept on State Migration
Management Policy of the
Republic of Azerbaijan", which
set the main goals before
executive bodies involved in the
implementation of migration
policy in the Republic of Azerbaijan,
was adopted in 2004.

For the purpose of realization of this concept and achievement of the determined goals the Order of the President of the Republic of Azerbaijan "On approval of the State Migration Program of the Republic of Azerbaijan (2006-2008)" was signed on July 25, 2006. Based on the Program, establishment of a special state body to implement a single state policy in the migration field emerged as an objective necessity.

President Ilham Aliyev signed the Decree "On establishment of the State Migration Service of the Republic of Azerbaijan" on March 19, 2007 taking into account that necessity.

The state policy implemented in the third phase of migration processes is also characterized



by the introduction of a number of innovations. Introduction of the "one-stop-shop" principle in the management of migration processes since July 1, 2009 in order to regulate migration processes through single and flexible procedures, to simplify documentation, establishment of the Unified Migration Information System (UMIS) - a unified system in the sphere of migration, and "Entry-Exit and registration" Interagency Automated Data Search System, and finally, adoption of the Migration Code of the Republic of Azerbaijan on July 2, 2013, provided a basis

for effective management of migration processes and these measures have once again demonstrated that migration policy is a priority for the Government of Azerbaijan.

Effective management of migration policy, as in many areas and directions, also requires active participation of civil society in these processes.

Establishment of public councils under the executive structures, in line with the "National Action Plan on Promotion of Open Government for 2012-2015", is an important event in ensuring the effectiveness of public policy implemented in this or other spheres. In this regard, organization of the activity of the Public Council under the State Migration Service, established on June 8, 2015, opened a new page on the implementation of migration policy.

Activities in organizational and structural directions covered issues, such as endorsement of the regulations of the Public Council, establishment and development of relations with government agencies, international and local public organizations, as well as establishment of working bodies of the Council. Particular attention has been paid to the establishment of effective communications with relevant executive bodies and the exchange of information in this regard.

The activity in theoretical and conceptual direction covered issues such as, strengthening of the migration policy, including expansion of the rights of foreigners and stateless persons,



protection of their legal interests, development of proposals for the purpose of improvement of legislation on regulation of migration processes and implementation of state control over migration processes, as well as other tasks in this direction. Activities in operational and tactical direction covers tasks directly related with migrants and are aimed at addressing their problems. Azerbaijani language courses were organized for 272 refugees and asylum seekers, 860 refugee families were provided with humanitarian aid and 250 refugees were provided with medical assistance by the Public Council. In addition, more than 400 migrant children who faced with education problems were provided with assistance. The Public Council pays special attention to the issues of public relations in its activity. Information sessions and "round tables" on public control, as well as video conferences on topical issues of migration with the participation of representatives of executive bodies and experts operating in the migration sphere in a number of CIS countries were organized. Articles were published in around

380 media sources, with reference to the members of the Council, as well as official page of the Public Council was opened on social networks.

The Republic of Azerbaijan managed to acquire vast experience in migration field and to build its own model in this sphere. The essential components of the policy implemented with regard to refugees and internally displaced persons, asylum seekers, as well as foreigners living and working in the territory of the country, including Azerbaijanis living and working abroad are integral elements of that model. Thanks to these elements, the state policy implemented in the field of migration in the Republic of Azerbaijan effectively addresses the problems arising in the sphere of migration and characterized with its actuality and is constantly reinforced and enhanced in to respond new challenges.

The MigAz is distinguished with numerous features. The mobile application operating in 3 languages creates opportunity to have access to services, such as registration upon place of stay, permissions for temporary and permanent residence, checking the status of application and travel ban, calculator for checking the registration deadline, online payment, online queue, ASAN visa, online guide, etc.

After downloading the mobile application, the notification on registration upon place of stay will be regularly shown in the screen. During the registration "push-notification" is sent to user. Foreigners and stateless persons intending to stay in the Republic of Azerbaijan for more than 15









The main privilege of the project "Migration volunteer - You are different!" is not only to promote formation of the youth as volunteers but also as future administrative leaders in the projects.








# For the sake of life without thalassemia!

Over the past period, the State Migration Service has successfully developed traditional multilateral cooperation with different organizations such as the United Nations (UN), the United Nations High Commissioner for Refugees (UNHCR), the European Union (EU), the International Organization for Migration (IOM), the International Center for Migration Policy Development (ICMPD), the Commonwealth of Independent States (CIS), as well as within the framework of Prague, Budapest and Almaty processes and has achieved a number of effective results.

Participation of the delegation led by the Chief of the Service Mr. Vusal Huseynov in the 18th meeting of the Board of Governors of the "International Anticorruption Academy" held on September 25-28, 2018 in the



Republic of Austria, his extensive speech at the 7th session of the Assembly of Parties, his meetings are some of the most important steps taken to expand existing relations with foreign partners. During the visit, Mr. Huseynov met with Deputy Director General of the ICMPD Gabriela Abado and discussed perspectives of future cooperation between our country and this organization.

Over the past year, six international projects covering various aspects of migration were successfully implemented in cooperation with IOM, UNHCR and ICMPD, significant results were achieved in terms of learning best practices. At present, appropriate measures are underway to agree new projects.

Within the framework of

readmission, voluntary return, migrants' social protection and other spheres. Important steps have been taken to expand the legal framework of our country with other countries in this area, as well. Thus, "The Agreement between the Government of the Republic of Azerbaijan and the Government of the Republic of Belarus on cooperation in the field of migration" was signed within the official visit of the President of the Republic of Azerbaijan Ilham Aliyev to the Republic of Belarus on November 19, 2019. It should be noted that this is the first bilateral



intergovernmental agreement on cooperation in the field of migration since the establishment of the State Migration Service. The agreement will play an important role in strengthening the legal framework for consolidation and development of mutually beneficial cooperation in regulating migration processes, exchange of statistical, scientific-methodological and other information of mutual interest in the field of migration and execution of relevant inquiries, protecting the rights of citizens of the Republic of Azerbaijan.

At present, work on the conclusion of such bilateral agreements and memorandums with other countries of mutual interest in the sphere of migration for our country is underway.

With particular emphasis on regular meetings and dialogue with international partners, bilateral meetings were held with officials of migration authorities of several countries. Thus, a

delegation led by the Chief of the Service made an official visit to the Netherlands at the invitation of the Repatriation and Departure Service of the country on January 28-31, 2019. On the basis of our invitations, a delegation led by Talal

Marefi, Chief of the General Directorate of Residency at the Ministry of Internal Affairs of the State of Kuwait, a delegation led by the Chairman of the State Migration Service of Ukraine Maxim Sokolyuk, a delegation led by the Deputy Minister of Internal Affairs of the Republic of Turkey Ismail Chatakli paid a visit to our country. In addition, a delegation led by the Minister of Internal Affairs of Montenegro Mevludin Nuhodzic visited our country to participate in the 5th World Forum on Intercultural Dialogue held in Baku on May 2-3 of this year at the invitation of the State Migration Service. Along with meetings in the State Migration Service during the visit to our country, the above-mentioned delegations also had discussions in the relevant state bodies of Azerbaijan.

During this period, the Service also had productive meetings with the heads of diplomatic missions of foreign states and businessmen.

Meetings of the Chief of the Service with the heads of diplomatic missions of EU member states in our country, as well as with representatives of business organizations, employers' associations and large companies operating in Azerbaijan on the establishment of the Advisory Council under the State Migration Service served to protect the rights and freedoms of foreigners and stateless persons visiting our country, living on the basis of relevant permits and engaged in paid labor activity, to solve problems in the field of migration in full transparency.

Furthermore, a public-awareness event with officials of more than 40 foreign diplomatic missions and consulates accredited in the Republic of Azerbaijan regarding innovations in the field of migration in our country held in the Service in January of this year once again demonstrated that the State Migration Service is always open to dialogue with all parties in the migration field.

Elaboration of appropriate migration policy is one of the key priorities for every state in the globalized world. Establishment of bilateral and multilateral cooperation among countries in this direction serves to safe, regular and orderly movement of migrants, as well as protection of their rights.









Inauguration of the Language Laboratory established to improve the language skills of the Service employees within the framework of the "Consolidation of Migration and Border Management Capacities in Azerbaijan" project, implemented with the main international partner of the Service International Organization for Migration, was held.

It should be noted that implementation of the "Consolidation of Migration and Border Management Capacities in Azerbaijan (CMBA)" project was launched in 2014. The project is implemented by the Ministry of Foreign Affairs, the State Migration Service, the State Border Service, the Ministry of Labor and Social Protection of Population and the Ministry of Internal Affairs of the Republic of Azerbaijan, as well as jointly funded by the EU, BP and its partners, the Bureau of Population, Refugees, and Migration of the US State Department, the US Agency for International Development.

### Prevention of illegal migration is always in the center of attention

Establishment of strong socio-political stability, increase of prestige in the international arena, successful implementation country. However, all of this should be regulated within the framework of the law". Thus, visa-free regime between Azerbaijan and a number

between Azerbaijan and a number

of transnational projects, strengthening of tourism potential, and support to the development of entrepreneurship has turned Azerbaijan from country of origin to the country of transit and destination in terms of migration.

Entry of 1.409.724 foreigners and stateless persons to the country was recorded at the border check points of the country during the first half of 2019 which is a clear example of the abovementioned idea.

The geographic position of the country plays a central role in case of intensification of migration processes. As President Mr. Ilham Aliyev mentioned, Azerbaijan opens its doors to all guests within the framework of the legislation: "The doors of Azerbaijan are open to each foreigner who arrives with good will. Foreigners can come, reside, work and study in our

of countries, as well as its transit role at the crossroads of Europe and Asia creates a favorable condition for illegal migration. Of course, there are illegal migration cases in all countries of the world.

Complex measures are carried out and the fight against illegal migration is always kept in the center of attention by the State Migration Service in order to prevent such negative impacts in our country.

Because, prevention of illegal migration is of utmost importance in terms of ensuring security of our country. It is an important factor for regulation of migration flows and implementation of the rights by migrants.

As a result of taken measures and investigations just within 6 months of the current year, 6327 decisions were made by the State Migration Service regarding infringement of the requirements of migration legislation, as well as administrative legislation of the country by foreigners and stateless persons.

3543 of the decisions were about the application of administrative fine without an administrative expulsion from the territory of the country for infringement of the requirements of the relevant articles of the Code of Administrative Offenses. 2337 out of them were about leaving the territory of the country, and 1206 were about the legalization of the





residence in the territory of the country.

Persons who illegally reside in the territory of the country, as well as who intend to obtain refugee status are placed at the Detention Center for Illegal Migrants of the Republic of Azerbaijan in Baku and Yevlakh cities, that meet international standards, for a period specified in the law until their legal status is determined, measures are implemented in the framework of the law, relevant decisions are made.

Furthermore, the State Migration Service always keeps in the spotlight organization of awareness raising campaigns on essence of illegal migration, its consequences and migration legislation. It is not a secret that one of the most effective tools against illegal migration is awareness raising events. Currently, notifications on registration upon place of stay prepared by the Service in Azerbaijani, Russian, English and Arabic are presented to foreigners and stateless persons entering to the country at the border crossing checkpoints, and various

awareness raising campaigns are conducted from time to time.

Moreover, information booklets on registration upon place of stay, extension of the temporary staying period, work permit, temporary and permanent residence rules, as The Service informs the public via its "Twitter" and "Facebook" accounts, "Youtube" channel, benefits from the opportunities of internet resources for preventing unawareness which is the first reason of illegal migration.

Furthermore, the Service's official webpage was improved in terms of content, technical and visual aspects, as well as accessibility.

The State Migration Service contributes to the national security of the country by timely and correctly implementing its duties, as well as taking effective measures against illegal migration.



well as state fees were prepared and relevant measures were taken towards delivering them to the target groups.

At this moment it should be noted that the State Migration Service also pays special attention to the utilization of the opportunities of social networks.

### Training of highly-qualified personnel in the sphere of migration is at the center of attention

The year of 2019 was declared "Training year" in the State Migration Service. Monthly and quarterly trainings have been organized to improve professional skills of Service employees in all structural units included in the system of State Migration Service. Trainings are implemented by highly-qualified, professional teachers.

In accordance with the Work Plan of Training Center of the State Migration Service courses embracing all activity directions of the Service are organized. The courses are held according to the following directions:



Foreigners and stateless persons engaged in entrepreneurship activity in the Republic of Azerbaijan are not required to obtain work permit.

- Organization of training process at a high level;
- Formation of moral and professional qualities;
- Preparation of teaching-methodical materials;
- Development and improvement of material-educational base;
- Preparation of qualified personnel in the sphere of migration;
- · Organization of capacity building and qualification courses.



Training Center of State Migration Service of the Republic of Azerbaijan also organizes courses for foreigners and stateless persons intending to obtain permit for permanent residence in the Republic of Azerbaijan in order to get acquainted with the language, history, culture of Azerbaijan, as well as legislation on rights and duties of foreigners and stateless persons. ### Significant international documents concluded in the field of migration

On December 17, 2018, "The Global Compact for Safe, Orderly and Regular Migration" was approved with 152 votes and "The Global Compact on Refugees" was approved with 181 votes by the UN General Assembly. These international documents drafted under the auspices of UN and approved by the governments cover all aspects of global migration. The agreements are non-binding documents indicating support to the international cooperation in the field of migration and respecting the sovereign right of the states. On September 19, 2016, heads of States and Governments came together for the first time ever at the global level within the UN General Assembly to discuss issues related to migration and refugees. At this meeting, the "New York Declaration on Refugees and Migrants" emphasizing the importance of enhancing comprehensive approach to the migrants' mobility by the UN Member States and cooperation at the global level was adopted. As a result, by taking into account the large-scale mobility of refugees and migrants, development of universal documents in the field of migration ("The Global Compact for Safe, Orderly and Regular Migration" and "The Global Compact on Refugees") was agreed in the Declaration.

The key goals of "The Global Compact for Safe, Orderly and Regular Migration" are as follows:

- To support international cooperation on the governance of international migration;
- To provide a comprehensive menu of options to address some of the most pressing issues around international migration;
- To give states the space and flexibility to pursue implementation based on their own migration realities and



capacities.

"The Global Compact on Refugees" is a framework for more predictable and equitable responsibility-sharing, recognizing that a sustainable solution to refugee situations cannot be achieved without international cooperation.

This Agreement is a referral document for governments, international organizations and other partners with the purpose of providing necessary support to refugees in their communities and living an efficient life. Furthermore, the Agreement is a unique opportunity for changing attitude of the world to the refugee problem by benefitting both refugees and the communities that host them.

The four key objectives of "The Global Compact on Refugees" are to:

- Ease the pressures on host countries;
- Enhance refugee self-reliance;
- Expand access to third-country solutions;
- Support conditions in countries of origin for return in safety and dignity.

We would like to emphasize that the Republic of Azerbaijan has demonstrated full support both to the discussion and adoption process of the Agreements, as well as voted for their adoption.



#### France proposes to reduce Schengen zone

President of France Emmanuel Macron expressed the idea to reform the Schengen zone.
Condemning several states on not being quite solidary in the field of migration policy Macron, noted that "Common borders, Schengen and Dublin Agreements no longer work".

### The photo of the girl crying for her mother at the border became "The best photo of the year"

The photo of Honduran toddler Yanela crying at the border between USA and Mexico was named as the winner of "The best photo of the year" nomination by the "World Press Photo" organization.

Photographer John Moore's winning image shows crying of daughter of Honduran woman Sandra Sanchez while U.S. Border Patrol officer pats down the child's mother. According to the words of Sanchez, she lost a month while crossing the territory of Central America and Mexico in order to reach USA for seeking asylum.

As a reminder, Trump Administration applied the policy of separating parents arrested during illegal crossing of U.S.-Mexico border from their children. However, public resonance and numerous criticisms occurred after this photo resulted with the revocation of the decision on June 20, 2018.





# The Global Migration Information Portal: An innovative electronic tool

It's been said that "data is the new oil", because like oil, data can generate value. However, it's the processing of data from collection, analysis, and dissemination and use that generates the real value. "Big data" (large-scale data collection) cannot create real value alone. In the field of migration, data (big data or vice-versa) reaches the highest value when it can be applied to better understand the complexities of migration and make policy decisions to address migration challenges.

#### Innovation addresses migration data challenges

Innovation is possible at each step of migration data processing, and if achieved, increases data's value. But, what is innovation in migration data?

Put simply, innovation in migration data are novel solutions to migration data's biggest challenges that allow data producers and users to obtain the most value or impact from data.

There are plenty of opportunities for innovation in migration data as the challenges in the organization of data are many.

#### For instance, migration data can be:

- fragmented and scattered
- not timely
- not comparable
- · not disaggregated
- not accessible
- too complex to understand

Even when migration data does exist, institutions may have limited statistical capacities to analyze data and disseminate information, or data systems containing migration-relevant data may work in siloes or be outdated, leaving migration data's vast potential untapped.

These data challenges were reiterated by the Prague Process Member States during the Tour-de-table at the Workshop on Gathering, Analysis and Sharing of Data, as well as participating representatives from several international organizations, in October 2018.

IOM staff from the Global
Migration Data Centre have also
heard echoes of similar
data challenges while at
data capacity-trainings and
migration data conferences
across the globe.

#### Innovation in migration data is burgeoning

With the increase in demand for migration data, especially in light of the 2030 Sustainable Development Agenda, these migration data challenges have come to the forefront, highlighting a need for innovation that will allow data producers and users to reveal data's potential. Recently, innovative efforts in migration data have been burgeoning. Here are a few examples to illustrate:

Currently, several regions are creating migration observatories, such as the Prague Process Migration Observatory that consolidates migration regional data, analysis and information to

inform the Member States' policy makers and experts. Regions are also launching online migration data platforms, such as IOM's Mesoamerica and Caribbean data platform that will be released in April 2019 and focuses the analysis, visualization and sharing of administrative data. Furthermore, initiatives that use big data or combine big data with traditional migration data sources have helped to forecast forced migration, to ensure better immigrant integration, and



estimate migrant stocks.

#### The Global Migration Data Portal as Innovation

Innovation is also happening at the global level. IOM's Global Migration Data Portal pulls together data, data sources, and information covering multiple migration topics in one place to help policy makers, national statistics officers, journalists and the general public interested in the field of migration, navigate the

increasingly complex landscape of international migration data.

- Making migration data easier to understand and information more digestible;
- Enhancing migration data capacity and literacy;
- Making migration data and information more accessible.

The Portal aims to address key migration data challenges and adds value by:

#### The Portal makes data easier to understand

Migration
data and

Visualizations of migration
data are a powerful tool to
reduce this complexity and help
audiences grasp complex sets of
ideas.

The Portal intends to simply migration data for all types of users through the interactive map's visualizations of data,

as well as the infographics found on the migration thematic pages. All infographics are available for downloading.

In addition, videos and blogs make the Portal a user-friendly resource to learn about migration data trends and current migration issues without having to scour countless academic journals and research papers.

#### The portal makes data more accessible

Migration is a cross-cutting issue and is increasingly being streamlined into a wide-range of policy areas, including development policies. However, migration-related data is usually not streamlined.

Currently, the most-frequent question from Portal visitors is

where to find migration datasets or information on specific topics.

To make migration
data more
accessible, the
Portal gathers together
more than 75 indicators on
international migration from 20
data providers in one interactive
ap.

As a result, users have the opportunity to perform more detailed research and analysis. Users can disaggregate the data by country, sub-region and region for more refined research and analysis, and by year using a sliding scroll bar.

Overviews of key migration statistics by region or country are also available. Portal users can also access key global, regional, and in some cases, national data sources for over 30 migration topics.

For policy and decision makers, the Portal provides a mapping of data sources available for all 23 commitments of the Global Compact for Migration. It also allows users to explore migration-related Sustainable Development Goals and relevant data sources by clicking on SDG

wheel.

#### Raising innovation is a main condition

Since December 2017, the Portal has grown its visitors to 500,000 users across 200 countries, signaling demand for migration data and statistics.

The Portal has also expanded its content and will continue to do so for the foreseeable future. In 2019, new sections on regional migration data, more datasets, thematic pages, tools, and blogs will be added.

But scaling innovation in migration data, like in any other field, is not without risks. One possible risk for initiatives that pool and share migration data and statistics is to become data graveyards.

This can happen for a variety of reasons, including the lack of resources. It can be difficult to make a case for investing in migration data innovation if it's not clear or convincing what real value or benefits will come of it.

Another possible risk is the breach of privacy and personal data rights. All innovations in migration data, especially those involving big data, should uphold privacy rights, ensure ethical standards and protect personal data.

Yet another possible risk is duplication. Partnerships are an ideal tool to avoid such cases.

Potential innovations for scaling data and issues regarding IDPs in the future, will play a significant role both in addressing challenges and development of relevant policy program, in any case.

## The State Migration Service consolidates cooperation with the private sector

Long-term and systematic activities in the field of sustainable and competitive economic development are carried out in the Republic of Azerbaijan. As a result of ongoing economic reforms and policies of economic diversification, development of the non-oil sector was ensured and significant progress was made in this area.

Minimizing dependence of the economy on oil and enhancing competitiveness based on development of entrepreneurship, improvement of business and investment climate were identified as one of the key strategic objectives.

In its turn, the State Migration Service contributes to the development of relations with the private sector and holds regular

meetings with entrepreneurs operating in our country, always focuses on creating

favorable conditions for businesspersons, as well.

A hotline was established to allow direct contact with the management of the State Migration Service, as a result of numerous meetings, in order to improve the process of issuing work permits, increase transparency and ensure prompt consideration of entrepreneurs' appeals. Inquiries received through the hotline are promptly answered by the Service.

Furthermore, the Advisory Council was established under the State Migration Service for the purpose of analyzing the difficulties that employers face, assessment of the impact of migration legislation requirements on the business environment in the country, and preparation of proposals aimed at supporting entrepreneurship.

The Council includes representatives of the State Migration Service, non-governmental organizations, as well as individuals and legal entities engaged in entrepreneurial activities involving foreign labor force. Meetings of the Council are held regularly. In addition, separate meetings were held with members of the Caspian European



Club, the American Chamber of Commerce (AMCHAM), the German-Azerbaijan Foreign Chamber of Commerce, the Turkey and Azerbaijan Public Association of Businessmen and Industrialists. The participants were informed about the changes in migration legislation, application of innovations, innovative approaches, perspective directions and numerous questions were answered during the meetings.

Taking into account proposals from business circles, in order to ensure the comfort of the persons arriving in our country to engage



in paid labor activity in Azerbaijan, employment visas were included in the list of electronic visas issued through the "ASAN Visa" system. The simplification and facilitation of this process will serve to the satisfaction of foreigners and stateless persons visiting the Republic of Azerbaijan for paid labor activity, as well as employers applying to the State Migration Service for work permits.

According to the Migration Code, the main grounds for foreigners and stateless persons to engage in paid labor activity in the Republic of Azerbaijan are the availability of a vacancy that cannot be filled by a citizen of the Republic of Azerbaijan who has the professional skills or qualifications required for such job and the inability of employment services to meet employers' needs in labor force at the cost of local labor resources.

Employers, in turn, must follow established procedures for

engaging foreign workers in paid labor activity. Violation of law should be avoided. They are simply required to respect the laws of the country.

#### "Nostalgia"

The article you are reading is based on a true story. The hero of the story is an asylum seeker who has been accommodated in relevant center of SMS voluntarily. She has found shelter in Azerbaijan escaping from the tortures she suffered from in her country. With hope of living safe, healthy and happy life in our country....

"The city of winds" has embraced her saving from the vise of hot, sandy land. It was the last hope of Elmira. My interviewer Elmira Mammadova (the name is symbolic) narrates:

- I'm the citizen of X Republic. My father was born in Baku in 1938. After graduating from Maritime Academy here he has entered Hashtarkhan Maritime Academy.

He has come back after finishing his education and worked in former Caspar port. "My father has lived in Icherishahar. Later he was sent on an official journey to X country. He has worked there as a captain. He met with my mother in that country. My mother worked at policlinic at the sea port then. They got married after a time."

Elmira is one of three children born from this marriage. The youngest child of the family. My interviewer recalls her childhood as a happy one. Memories related to Baku also exist in her unforgettable years:

- I have spent all my summer holidays in Baku, at my grandmother's. I knew every corner of Old City, streets at "5 martaba" and Boulevard very well. I still remember me going by tram from H.Hajiyev street to "Shamakhinka". There was a bazaar in the area referred to as "5 martaba". It was called "Shamakhinka" then. There were carousels, bridge heading to the sea and small restaurant "Sadko" at the bottom of the bridge. (She is lost in thought).

Elmira makes an imaginary journey to those years through the bridge heading to the sea. Old Baku, benevolent, kind people and songs of Muslum Magomayev, Polad Bulbuloghlu playing in the balconies.

- Though I was born in X Republic, I was always a stranger there. Very hot and sandy land. I got married in X Republic, my children were born there. In spite of this, I have always been connected with Azerbaijan, with Baku spiritually. This love has influenced my children as well.

Elmira has inherited this love from her father. She says her father who was a ship captain has travelled various countries. But he has always noted that he has never been to any place more beautiful than Azerbaijan, than Baku port.

Years pass away. After the downfall of USSR many people with Azerbaijani nationality like Elmira are deported from their places of residence. The spring of life which was like a fairy tale was replaced with defoliation of the autumn.

- We were openly told that, there was no place for us in that country, we had to return to our Motherland. We lost our jobs as it was written "Azerbaijani" in our passport. People had to leave the country selling their property cheaply. My brother was an entrepreneur. He was killed and we were expelled.

Elmira struggles for surviving

and takes refuge in her beloved Azerbaijan. She comes to her sister who has lived for 33 years in Baku and who was the citizen of Azerbaijan. She also buries her parents in Baku. Now Elmira hopes for the best future leaving behind all the difficulties she has faced.

- I have great expectations for obtaining Azerbaijani citizenship. I have a firm belief that my wishes of living and working in the country I have been proud of, I have believed in since my childhood will come true. he hero of the story is Adara (conditional name), a girl who was able to carry the hardships of life on her delicate shoulders from a very early age. She was a resident of a society dominated by strange customs. Instead of going to school as her peers, she was married by her family at a very early age... Strangely enough, in the XXI century we still have "parents" who marry their daughters for money and property.

Adara remembers this event: "When I was 13, my father married me to a man named Firat (conditional name) in exchange for a bride wealth. I lived with him for four years. I was young and I didn't know what marriage, family, husband was, but I was playing with my doll. That is why my husband beat me and repeatedly hit my head on the wall".

At that time Adara gets pregnant. Despite the doctors' ban, she has to keep the baby at her husband's insistence and she undergoes a surgery that almost costs her life.

Adara becomes a mother at an age when she still needs her mother's love and affection. But she is unlucky again. The worst punishment for a woman is the loss of her baby, her longing for the smell of her baby "My husband didn't show me my daughter. He took the child away from me, did not let me breastfeed the baby and take her in my arms, he wanted to "teach" me a lesson for no reason. My husband's aunt took my daughter away from me somewhere".

Fate leaves our hero alone and teary at a very early age in times of stress and distress. Adara, who couldn't endure suffering, gets divorced and leaves the village, she decides to look for her parents. In spite of her struggle and resolute attempts, she cannot find her close relatives. Strangely enough,

her relatives do not even mention whereabouts of her parents, who changed their address and she is directed to the wrong address - to other cities and towns in a foreign country. Wandering the cities with hope, Adara goes to her maternal uncle's house:

"I went to that city and asked my uncle's wife.

the police for deportation with a desire to return to her country, return to her native city and at least walk the streets and roads that she knows, with the desire for mercy, ordinary humanity and care in her homeland, and most importantly, with the desire to meet her sister. The deported Adara has to stay at a police station in the border area of her homeland for a while.

According to her family and relatives who have become "slaves" to traditions, Adara was a disgrace by divorcing from her husband and leaving the house. Adara's hopes come to nothing again and she loses all hope in her family, she becomes the lonely inhabitant of the great world: "You have disgraced all of us by leaving your husband's house. You have no place in our house", my sister said to me".

People who do not know her help the lonely woman rejected by her close relatives, they show her what the right thing is to do and support her to succeed in life. She takes refuge in one of the small towns and starts working in a beauty salon, her face is gradually smiling. After a while she starts to work as an ordinary policewoman. Adara, who is afraid to face immoral suggestions at work, even hides that she has ever been married before, often changing her address. In spite of all these, her ex-husband does not leave her alone here. Although she moves to a new address, every time her ex-husband finds her, threatens her, beats her and tries to burn her.

Adara is very happy when she learns from her boss that she

can go abroad to improve her education to become an officer. She is now thinking confidently of future with new plans. She is going to apply to the police of the country where she is going, she thinks this will save her from her husband's threats. Unfortunately, persecution does not stop there.

Adara returns to her country and complains to the local police. Even though they detain her ex-husband 2-3 times for that, they have to release him again. Living with impunity at the expense of high-level contacts and acquaintances, Firat does not abandon his evil deeds.

Adara: "My ex-husband was very rich. One day, he came in and talked to my new boss and had me assigned to a very dangerous area. The area was a place under the control of armed extremists and if I were to go there, I might not come back..."

Today everything remains in the past for Adara, whose life was turned into hell by her family in the cities where she went to save her life. She is brave and capable of fighting for her life. "I am not a woman who you can entertain with, if we are going to marry, I agree, but I will never meet you otherwise" these words of her made her to be loved and united with a man whom she loved too.

After her marriage, she and her husband arrived in Azerbaijan where stability and tolerance prevails. They are here for the second chance of their lives with the hope of a healthy, happy future to live together...

Adara says she is convinced that Azerbaijan is the only country where they will be happy.

#### DO YOU KNOW?



Foreigners and stateless persons married with the citizen of the Republic of Azerbaijan are not required to obtain a work permit for carrying out paid labor activity in the territory of the country.

\*\*\*\*

Investment in the amount of at least 500.000 manats to the country's economy by foreigners and stateless persons is a ground for issuing them permit for temporary residence in the territory of the Republic of Azerbaijan for the duration not exceeding 3 years.

\*\*\*\*

In case labor contract between an employer and foreigner or stateless person prematurely terminated, employer should inform the State Migration Service within 5 working days about this.

\*\*\*\*

Foreigners and stateless persons residing in the Republic of Azerbaijan can apply to the Training Center of the State Migration Service in order to get acquainted with the language, history, culture of Azerbaijan, as well as legislation on rights and duties of foreigners and stateless persons. We would like to notify that, the courses are free of charge.





















#### Mobile services









With the purpose of receiving and promptly processing of applications made to the State Migration Service (SMS) mobile services are regularly organized in the regions.

A mobile service ensures access to the services rendered by the SMS for citizens residing in remote villages and encountering challenges to apply directly to the Regional Migration Departments of the SMS.

While 20 mobile services were rendered in 2018, this number was 16 during the first half of 2019.

#### read - I knew

I have come to Azerbaijan for vacation with my family members and we have 5 days left before expiration of our visa. I suppose we will be unable to leave the country in time due to sudden health problem of my child. Can we extend our visa on this ground?

\*\*\*\*

- In compliance with the Migration Code temporary stay of a foreigner, his father, mother, sister and brother can be extended up to 60 days when urgent medical treatment is required.

I have rented my flat to a foreigner in compliance with the legislation and have submitted an application for his registration. But that foreigner has moved from my flat violating the contract. Which measures will be taken in compliance with the legislation in case of submitting application for deregistration of that person?

\*\*\*\*

- In compliance with the migration legislation in case the person who has applied for the registration of a foreigner has submitted an application for deregistration of that foreigner, that foreigner has to submit documents certifying his registration in other settlement within 10 working days, otherwise, he will not be issued temporary or permanent residence permit or its period will not be extended.

I have to pay a business visit to a foreign country. Temporary residence permit for a year in the territory of the Republic of Azerbaijan is required for obtaining visa from the relevant embassy. Is it possible to obtain that permit within a short period by paying state fee?

\*\*\*\*

- In accordance with the law on state fee you can obtain temporary residence permit within
15 working days by paying state fee in the amount of 160 manats.
